ORDER

As per notice of DGHS, Medical Counselling Committee, Govt. of India, Nirman Bhavan, New Delhi, bearing number U-12021/44/2019/14-MEC, dated 08-04-2020, results of Round-1 PG Counselling (AIQ) will be declared by 10th April 2020. The allotted candidates have been instructed to report to the colleges from the date of declaration of results of Round-1 to 20th April 2020. The allotted students will be admitted TOTAL PROVISIONALLY to the respective specialty as Junior Resident 1st Year from the date of joining the course in the concern department. The Degree/Diploma Shall be of three/two year duration respectively. The P.G. course and residency will be governed by recommendations of the MCI and rules, regulations & ordinance of Dr. B.R. Ambedker University, Agra. The GOs of UP Government concerning residency scheme will be applicable on such students including for pay & allowances. In order to complete the admission process, following steps need to be completed-

- 1- Fee Deposit -as per following break.up
 - a. Tuition Fee = Rs. 24,000.00 p.a
 - b. Other Fee = Rs. 4000.00 p.a.
 - c. Admission Fee = Rs. 2000.00 (One Time)
 - d. Development Fee = Rs. 2000.00 p.a.
 - e. Caution Money = Rs. 10000.00 (One Time, Refundable)

Those candidates opting for seat upgradation in 2nd Round Counselling can pay partial tuition fee of Rs. 5000/- only, Remaining Tuition fees and caution money can be paid after confirmation of seat in 2nd Round NEE-PG-2020, (AIQ) within 3 day's of declaration of 2nd Counselling result.

- 17- Course completion Bond Rs. Five lacs. (To be submitted in original at the time of physical appearance).
- 18- Two year compulsory service Bond. (To be submitted in original at the time of physical appearance).
- 19- Declaration on a plain paper - "whether the candidate wants to opt for 2nd round of counselling or not.
- 20- Hand Written and self Attested Undertaking by the candidate stating as under on separate paper.

- a- "I hereby declare that all the information given/ uploaded by me in the application is factually correct and true to the best of my knowledge and belief. I undertake that in the event of any information being found false or incorrect at any stage, my candidature is liable to be cancelled and I will have no claim on the seat allotted to me by the competent authority."
- b- I have read and understood the rules of Bond applicable I shall follow and abide by all the rules of U.P. Govt. Failing which my admission is liable to be cancelled and I shall have no claim on this Seat in Future.
- c- In Case do not join the department after admission or resign any time from the course during the study period after second counselling, I will have to deposit the BOND MONEY Rs. 5-00 Lacs (Rs. Five Lacs only) along with the entire salary received by me during the study period. The admission fees and security money will be forfeited even if it has been reimbursed.
- d- I Know that Compulsory Govt. Service Bond of two years period has to be full filled by me. In case of failing to serve the bond an amount of Rs. 40 Lac (Rs. Four Lac only) for M.D./M.S and 20 Lac (Diploma) bond money will have to be paid by me.

Hereinafter referred to as ("FIRST PARTY") of the one part

Governor of Uttar Pradesh (here in after referred to as "Government") of the Second Part.

WHEAREAS FIRST PARTY has applied for admission to ----- course and FIRST PARTY has been selected to the said course. As per the Prospectus, the FIRST PARTY has agreed to serve the Government for a period not less than two year after successful completion of the -----course. If the FIRST PARTY fails to serve the government for a period of two year the FIRST PARTY shall forthwith pay a sum of Rs. 40 Lacs for Degree and 20 Lacs for Diploma, MDS to Government at the specified Government Treasury. During the above period the FIRST PARTY shall be paid Stipend and the Government will request their services within a period of three months from the date of successful completion of the ----- course. In case the Government does not provide services in mentioned period, the BOND shall be released; AND WHEREAS the FIRST PARTY has also agreed that on successful completion of the ----- course his/her certificates relating to ----- course will not be given to the FIRST PARTY unless the FIRST PARTY successfully Serves the Government for a period of two year or pay to the Government on demand the sum of Rs.----- (Rupees -----) only.

If the FIRST PARTY fails to deposit the aforesaid amount in specified period, FIRST PARTY shall be liable to pay interest at the rates specified by the Government as per applicable law during the period 'of delay: AND WHEREAS the Government have, at the request of the FIRST PARTY ----- employed as -- ----- granted stipend to him/her for a period of 24 months effect from -----in order to enable his/her to study at ----- college.

AND WHERE AS if the FIRST PLARTY ----- work s for a period of less than 24 months during the ----- Super specialty course DM/MCH/--- ----- Post Graduate Degree MD/MS/Diploma/MDS/Graduate Degree MBBS/BDS course, the proportionate amount will be treated as stipend and the FIRST PARTY ----- shall pay back in addition to the security amount of Rs.....(Rupees----- only) the balance amount of stipend to the Government. This bond shall in all respects be governed by the Laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.

NOW THIS DEED OF AGREEMENT BOND WITNESSES AS FOLLWOS: -

1. The FIRST PARTY has agreed to serve the Government for a period of two year on successful completion of the ----- Super specialty course DM/MCH/Post Graduate Degree MD/MS/Diploma/MDS/Graduate Degree MBBS/BDS course. If the FIRST PARTY fails to serve the

- Government for a period of two year, FIRST PARTY shall pay forthwith a sum of Rs. -----
(Rupees -----only) to the Government in the specified Government Treasury.
2. The FIRST PARTY Agrees that till the successful completion of the period of two year service to the Government or till the payment of Rs. ----- (Rupees -----) only is paid the certificates relating to ----- Super specialty course DM/MCH/-----Post Degree MD/MS/Diploma/MDS/ Graduate Degree MBBS/BDS course shall be in the custody of the Concerned Institution/University/College and the Government has a First lien over all the certificates gained by the candidates at the time of admission.
 3. The FIRST PARTY authorizes the Concerned Institution/University/College for retention of the certificates till the lien of Government is cleared/discharged.
 4. This BOND shall in all respect be governed by the Laws of India, for the time being in force, and the rights and liabilities shall, where necessary, be accordingly determined by the appropriate courts in India.
 5. If the FIRST PARTY fails to deposit the aforesaid amount in specified period, FIRST PARTY shall be liable to pay interest at the rate specified by the Government as per applicable law during the period of delay, failing which Government shall have right to recover the aforesaid amount together with interest as arrear of land revenue.
